### **Corporate Finance Theory Symposium 2016**

The third Corporate Finance Theory Symposium took place in Cambridge on  $16^{th}$ - $17^{th}$  September 2016. The symposium included nine high quality papers in the broad area of corporate finance theory. The symposium attracted international speakers and discussants. The keynote was given by Professor Anjan Thakor. The symposium attracted over 40 attendees.

The event comprised research presentations by Dr Chryssi Giannitsarou (Faculty of Economics, University of Cambridge), Dr Bang Dang Nguyen (CJBS), Dr Jenny Chu (CJBS) and Professor Raghu Rau (CJBS). Presentations were followed by short Q&A and discussions.
